

# How You Can Help Clean up Colorado Voter Rolls Boulder County - 2022 General Election

The Boulder County Republicans is announcing a new way for voters to participate in cleaning up the voter rolls while at the same time reducing the costs of our mail in voting system. We need all Colorado voters to *carefully* follow this simple procedure for any mail ballots that arrive for someone who does not reside at a residence where they live, work, or receive mail.

## **UNDELIVERABLE BALLOTS: Follow this process for ballots sent to voters who are:**

- Deceased or for any adult children who have moved away;
- Previous residents and/or tenants who no longer live at an address;
- Former residents who no longer reside at a health facility, group home, rehabilitation center;
- Dorm residents or college students no longer living at that location;
- Any mail ballot that goes to an address where a voter does not currently reside or receive mail.

**Step 1:** Leave the mail ballot envelope sealed. **DO NOT** open the envelope. **DO NOT** throw it away. **DO NOT** damage nor destroy the document. **NEVER** forward it nor give it to anyone else.

**Step 2:** Write directly on the mail ballot envelope: **“Return to Sender - Undeliverable.”** For voters who have passed away, write: **“Deceased - Undeliverable”**. **DO NOT** write over nor cover up the voter’s name, address, or the barcode portion. **DO NOT** write on any mail that is sent to addresses other than your own address(es). This is very important!

**Step 3:** Write down the undeliverable voter’s name, address and why it was undeliverable (likely one of the reasons above), take a picture of the outside of the envelope, email this information to the address below and the date you dropped in a USPS Box.

**Step 4:** Send an email to our County email address: [boulderregistrationchk@proton.me](mailto:boulderregistrationchk@proton.me) with the name of the voter on the envelope and their address. Please also email your photo image of the envelope if you can. Election Integrity volunteers will research the voter to see if that voter should be challenged. If so, you will be sent a voter challenge form to complete and submit to the state to correct the voter record.

**Step 5:** Place the ballot envelope in a United States Postal Service (USPS) mailbox, no postage needed. Note: **DO NOT** place in drop-off boxes. **DO NOT** return it to the Clerk & Recorder’s office nor take it to a polling location, nor drop it off at ANY other locations. It must go back through the USPS and be marked “undeliverable” to trigger the appropriate process.

**Step 6:** Encourage everyone you know to check their own voter registration at [www.govotecolorado.gov](http://www.govotecolorado.gov) and to track their ballot by signing up at <https://ballottrax.com>

Your involvement now can result in fewer ballots being sent out to incorrect addresses for future elections, **reducing costs as well, saving about \$1.15 to 2.00 per ballot or \$200,000 to \$300,000+ in mailing costs per election in Colorado.** The voter that no longer resides at the location will be marked inactive, and ballots will no longer continue to be sent out to that address. After a time, the voter’s registration will be canceled unless the voter acts on their voter registration.

**MISSING BALLOTS: Did Not Receive your Election Ballot:** If you are a registered voter and do NOT receive your election ballot in the mail, first check [ballottrax.com](http://ballottrax.com) to see what the state system says about your ballot and check the accuracy of your registration at [www.govotecolorado.gov](http://www.govotecolorado.gov) If your registration was already correct, please notify us at: [boulderregistrationchk@proton.me](mailto:boulderregistrationchk@proton.me)
